# Carbon Korea 2023 Exhibition Participation Rules

## **Article 1. Definition of Terms**

1. "Exhibitor" refers to an individual, company, association, or organization that has submitted an application for participation in this exhibition.
2. "Exhibition" refers to the Carbon Korea 2023
3. "Organizer" refers to Korea Carbon and Nano Industry Association(KCANIA)

## **Article 2. Application for Participation**

1. Those who wish to apply for participation in the exhibition must fill out an application for the usage of the exhibition area/booth(s) and submit it to the organizer. If there is no space left in the exhibition or if it is judged that the items to be exhibited are not suitable for the exhibition, the organizer may refuse to accept the application for participation.
2. It is to be understood that by submitting an application for participation and by receiving a confirmation letter, the exhibitor has read and agrees to adhere to the rules for participation of this exhibition.

## **Article 3. Allocation of Exhibition Areas**

1. The organizer will allocate the exhibition location for each exhibitor according to the order of receipt of applications, application area, characteristics of exhibits, and other reasonable methods.
2. The organizer may change the location of an exhibition booth assigned to an exhibitor at any time before the exhibition installation period in case of special circumstances. Such changes are at the discretion of the organizer, and the exhibitor cannot claim compensation for the results of such changes.

## **Article 4. Exhibition Hall/Booth Management**

1. The exhibitor shall only showcase products that fall under the classes of products the exhibitor had specified in the exhibition participation application form and agrees to arrange and provide the necessary manpower needed to manage the exhibitor's booth independently during the exhibition period.
2. If necessary for the smooth operation and safety of the exhibition, the organizer may restrict the entry of specific persons to the exhibition hall.
3. Exhibitors may not transfer all or part of their allocated exhibition area to another person/entity without the written consent of the organizer.
4. Exhibitors may not change the original appearance of the exhibition hall by painting the floor, ceiling, pillars, walls, etc., and in case of damage to the exhibition hall, must compensate by covering all expenses related to restoration.

## **Article 5. Cancellation by the Exhibitor**

If the exhibitor gives up or refuses to use the agreed exhibition area without the organizer's

approval, the organizer may cancel the exhibitor's application for participation.

#### **Article 6. Cancellation or Changes to the Exhibition by the Organizer**

If the organizer cancels the exhibition, all of the exhibitors should be noticed about Cancellation. If the exhibition is canceled or the date/location of the exhibition is changed or the size of the exhibition is reduced due to force majeure or other special circumstances not attributable to the organizer, the exhibitor cannot claim compensation from the organizer.

#### **Article 7. Exhibition and Display of Exhibited Products**

Exhibitors must complete display configurations and bring and install exhibition products in their allocated booths within a designated period at the expense of the exhibitor.

#### **Article 8. Removal of Exhibited Goods and Installations**

Exhibitors must remove all exhibited products and installations from the exhibition hall within a designated period. Should there be delays in removal, the exhibitor must immediately pay to the organizer all expenses accrued due to such delays.

#### **Article 9. Exhibition Hall Safety, Risk and Insurance**

1. The organizer shall take appropriate security measures for exhibitors and visitors.
2. Exhibitors take full responsibility for damage to and theft of installations and exhibited products within their allocated areas during the installation period, exhibition period and demolition period.
3. In the event that fire, theft, damage, etc. occurs, whether intentionally or negligently, by the exhibitor and causes damage to the organizer or others, the exhibitor is fully responsible for all related compensation. The exhibitor is solely responsible for insurance for exhibited items

#### **Article 10. Compliance with Safety Management Regulations and Fire Prevention Regulations**

1. Installations and all materials in exhibition booths must be properly non-combustible in accordance with fire regulations.
2. Exhibitors must comply with organizer requests to inspect and correct exhibition booth installations and materials that do not adhere to AT center(Seoul) safety management regulations and fire prevention regulations.
3. Exhibitors must comply with AT center(Seoul) safety management regulations and fire regulations. In particular, the use of gas heating appliances is prohibited; should there be an unavoidable need, electric heating appliances can be used instead with the prior approval of the organizer.

#### **Article 11. Supplementary Provisions**

1. If necessary, the organizer may establish supplementary regulations not specified in this participation agreement.
2. Supplementary regulations become part of the participation agreement and the exhibitor must comply with them.

#### **Article 12. Dispute Settlement**

In the event that a dispute between the organizer and an exhibitor arises in relation to this exhibition participation regulation, both parties shall make every effort to resolve the dispute amicably. Disputes not resolved amicably shall be resolved by the Seoul Central District Court.
